A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING WAIVING OF BIDDING FOR SOLE SOURCE ITEMS NOT COVERED UNDER STATE CONTRACT AND FOR ACQUISITION OF MATERIALS AND SUPPLIES, WITH THE ACQUISITION BEING FUNDED FROM THE LAW ENFORCEMENT TRUST FUND AT A COST NOT TO EXCEED \$60,000.00.

NOW, THERE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida, hereby approves waiving of bidding for sole source items not covered under state contract and for the acquisition of equipment and materials to provide efficient and enhanced police services with the acquisition being funded from the Law Enforcement Trust Fund at a cost not to exceed \$60,000.00.

SECTION 2: That the Mayor and City Manager are hereby authorized and directed to execute a contract for the above, or the administration is authorized to issue a purchase order for same.

SECTION 3: That this Resolution shall become effective immediately upon its passage.

SUBJECT: **AGENDA REQUEST -- ACQUISITION OF EQUIPMENT AND MATERIALS**

In a continuing effort to support community policing activities, training, law enforcement operations, as well as efficient and enhanced police services, the need to expand and update our equipment and material resources is essential. In this regard, we have identified a number of equipment and material resources that are needed to facilitate our mission. This includes, but is not limited to the following:

1. Acquisition of specialized carbine racks, firearm supplies and equipment.
2. Equipment and training needs for the Selective Enforcement Team (SET), Special Response Team (SRT), Special Operations Division (SOD), and Crisis Negotiation Team (CRT).
3. Acquisition of uniform tactical vests designed for high visibility tactical operations and deployment.
4. Traffic crash investigation equipment, to include acquisition of Crash Data Recorder (CDR).

For those items that are not covered under state contract and are sole source, we request waiving of bidding.

Due to law enforcement need for this equipment, and absent appropriated funds, I am requesting to fund this acquisition via the Law Enforcement Trust Fund Account. This acquisition shall not exceed \$60,000, and is an appropriate expenditure under permissible uses of equitable shared funds that are necessary to perform official law enforcement operations.
