**TED DEUTCH FOR CONGRESS**

Contributions or gifts to Ted Deutch for Congress Committee are not tax-deductible. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals who contribute in excess of \$200 in an election cycle. Federal law requires that only personal funds or funds from federally registered Political Action Committees (PAC) can be accepted. Corporate checks or funds, funds from government contractors and foreign nationals, and contributions made in the name of another cannot be accepted. Individuals may contribute up to \$2,700 per election (\$5,400 for the cycle) and Political Action Committees may contribute up to \$5,000 per election (\$10,000 for the cycle).
