

## **CITY OF MARGATE, FLORIDA JOB DESCRIPTION**

**JOB TITLE: CHIEF PLUMBING INSPECTOR (Job Code 185).**

---

### **GENERAL STATEMENT OF JOB**

Under general direction is responsible for supervising and performing inspections of a wide variety of plumbing installations and alterations for compliance with the state and municipality's plumbing and building codes. Position performs responsible technical enforcement work in the inspection of new and existing installations and systems to determine and secure compliance with the Florida Plumbing Code. Work involves technical examinations and the application of standard trade practices to inspection work. Inspections are conducted independently but in accordance with Building Department regulations and established technical standards. Position analyzes current and proposed plans and specifications for the purpose of ensuring compliance. Supervision is received from the Director of the Building Department.

### **ESSENTIAL FUNCTIONS**

**The following duties and functions, as outlined herein, are intended to be representative of the type of tasks performed within this position. They are not listed in any order of importance. The omission of specific statements of the duties or functions does not exclude them from the position if the work is similar, related, or a logical assignment for this description. Other duties may be required and assigned.**

Supervises the work of subordinate plumbing inspection personnel where applicable.

Inspects new and existing plumbing systems and installations in residence, business, commercial and other buildings for conformance with safety and other requirements of the building and plumbing codes.

Examines plans and specifications for new plumbing systems and remodeling plans and installations in residential, commercial and industrial buildings for compliances with safety and other requirements of the building and plumbing codes and the issuance of permits.

Investigates complaints of defective plumbing systems and installations which are reported as potential hazards, notifies responsible persons of defects, and issues oral and written instructions for correction.

Performs second inspections and reports violations, and assists in representing the City at court hearings.

Advises plumbers, builders, owners, contractors and architects on the application of the Florida Plumbing Code, and interprets and reviews codes, standards and departmental regulations, recommending changes when needed.

Prepares daily and monthly reports of inspections performed covering conditions found, actions taken, and recommendations made for further action, as well as names of owners, builders and address of inspections.

Performs related work as required.

## MINIMUM TRAINING AND EXPERIENCE

Must possess high school diploma or equivalent. Must possess and maintain valid Florida Driver License. Must be certified by State of Florida Building Code Administrators and Inspectors Board as a Plumbing Plans Examiner and Gas Inspector. Must have ten (10) years' experience as a Master Plumber, Plumbing Contractor, five (5) in the plumbing discipline and two (2) years as a Plumbing Inspector. Possess current Certificate of Competency as a General Contractor (unlimited) issued by one of the following: Florida Construction Industries Licensing Board or Broward County Central Examining Board of Building Construction Trades (as class A) Unlimited General Contractor or Dade County Construction Trades Qualifying Board, Block proctored, issued on or after January 1, 1968 or Florida Department of Business and Professional as a Registered Architect or Professional Engineer.

## MINIMUM QUALIFICATIONS OR STANDARDS REQUIRED TO PERFORM ESSENTIAL JOB FUNCTIONS

Physical Requirements: Tasks involve frequent walking, standing, bending, stooping; some lifting and carrying objects of moderate to heavy weight (20 – 50 pounds).

Date Conception: Requires the ability to compare and/or judge the readily observable, functional, or composite characteristics (whether similar to or divergent from obvious standards) of data, people, or things.

Interpersonal Communication: Requires the ability to speak and/or signal people to convey or exchange information. Includes giving and receiving instructions, assignments and/or directions.

Language Ability: Requires the ability to read a variety of technical materials relevant building regulatory practices moderate to complex levels. Requires the ability to read various discipline languages, i.e., engineering, mechanical, electrical.

Intelligence: Requires the ability to analyze and interpret complex problems, and draw valid scientific conclusions in regulation and analysis and interpretation. Requires the ability to utilize principles of synthesis.

Verbal Aptitude: Must communicate efficiently and effectively in standard English. Must speak with poise, confidence, and voice control.

Numerical Aptitude: Requires the ability to add, subtract, multiply and divide; interpret graphs; calculate decimals and percentages; perform algebraic and geometric equations.

Form/Spatial Aptitude: Requires the ability to inspect items for proper length, width and shape, and visually read various information.

Motor Coordination: Requires the ability to coordinate hands and eyes accurately for inspection tasks and report preparation.

Manual Dexterity: Must have minimal levels of eye/hand/foot coordination.

Color Discrimination: Requires the ability to differentiate between colors and shades of color.

Interpersonal Temperament: Requires the ability to deal with people from a variety of departments and backgrounds in both giving and receiving instructions. Must be able to perform under stress of frequent deadlines.

Physical Communications: Requires the ability to talk and/or hear: (talking: expressing or exchanging information by means of spoken words; hearing: perceiving nature of sounds by ear).

Environmental Requirements: Tasks require infrequent exposure to adverse environmental conditions.

## **KNOWLEDGE, SKILLS, AND ABILITIES**

Knowledge of the materials, methods and practices involved in construction, installing and operating a variety of plumbing systems, installations, and equipment.

Knowledge of possible defects and faults in plumbing systems and installations, of standard testing devices and of effective corrective measures.

Skilled in both written and oral communications for effective expression of concepts and proposals, and clarity in task assignment.

Ability to detect and locate defective plumbing system and installation construction, and to ascertain the stage of installation when defects are most easily found and remedied.

Ability to read and interpret wiring diagrams and specifications for plumbing systems and installations, and to recognize deviations from such plans in the construction process.

Ability to enforce codes and regulations firmly, tactfully and impartially.

Ability to establish and maintain effective working relationships with contractors, property owners, representatives from other agencies and the public.

Ability to supervise subordinate personnel.

Ability to analyze, organize and review work for efficient results and accuracy.
