



## ANIMAL DISPLAY PERMIT APPLICATION CHECKLIST

- Application Processing: Applications and payments are only accepted online through [ProjectDox](#)
- Complete Application: Incomplete applications cannot be accepted.
- Temporary Use Application: Animal display permits can only be issued in conjunction with a Temporary Use Permit.
- Owner's Authorization Affidavit: If owned by a corporation an authorized agent registered with the State of Florida as listed on [www.sunbiz.org](http://www.sunbiz.org) must be the person that signs and the record from [www.sunbiz.org](http://www.sunbiz.org) must be provided. If the person signing is not listed as an authorized agent, then a corporate resolution showing that person is authorized to sign on behalf of the corporation may be provided.
- Animal licenses: A copy of any and all federal and state licenses and permits required for authorizing such exhibit or display.
- Disclosures: A disclosure of any and all prior and ongoing investigations conducted by a law or code enforcement entity relating to animal cruelty, abuse or neglect, including a summary of the issues being investigated and the outcome of the investigation.
- Veterinarian Certification: Completed city form and proof of an examination of EACH animal to be displayed from a Florida licensed veterinarian within the last 90 days.
- Animal Housing and Care Protocols: A detailed description of the facilities and procedures to house and care for the animals during the display.

## ANIMAL DISPLAY INFORMATION

### Time limit:

- Each animal display permit shall be valid only for a period of time consistent with the approved temporary use permit; provided, however, that no extended license shall be granted to other than a USDA-licensed animal exhibitor.
- No applicant may obtain more than four (4) permits within a one (1)-year period.

### General:

- The permit shall be displayed prominently at the site of display.
- There shall be no exhibition or display of any sick, injured or crippled animal.
- The use of techniques and devices that cause physical injury, torment, or pain and suffering to animals are prohibited.
- The animals shall not be kept or displayed in an environment that endangers the health or safety of the animal or the people and property in the surrounding area.
- The animals must be kept in appropriate housing and husbandry conditions including regular access to food, water, shade from direct sunlight, shelter from inclement weather, nest boxes or dens, relief from human interaction, and veterinary care, as applicable.
- The keeping or harboring of any animal or fowl whereby frequent or habitual howling, yelping, barking, crowing or making of other noises that annoys or disturbs a reasonable person of normal sensitivities across real property boundaries is prohibited.
- Each animal to be exhibited or displayed has been examined by a veterinarian licensed to practice in Florida within the past 90 days and is in good health and fit and suitable for the purposes of its display.
- Each animal to be exhibited or displayed is not of a species appearing on the federal List of Endangered or Threatened Wildlife [(50 C.F.R. § 17.11(h)] or a hybrid of any such species of an exotic, threatened, or endangered species as defined by the United States Department of the Interior.

## TERMINATION OF ANIMAL DISPLAY PERMIT

The city, through officers of its code compliance division or police department may terminate any exhibition or display of live animals if, in their discretion, said display or exhibition violates any portion of this section. Prior to termination of the exhibition or display, the animal exhibitor or his representative or employee, if available at the site of display, shall be informed of the danger posed by or objection to said exhibition or display, and shall be given an opportunity to correct or remedy same if the danger or condition is immediately remediable. Failure to take immediate action by the exhibitor to correct the condition or danger as required shall result in the termination of the exhibition or display by the officer.
