Pursuant to Section 40.618.(x), Code of the City of Margate, Florida, all wireless communications facility owners (which include antenna support structure owners **AND** wireless facility tenants with equipment on antenna support structures) are required biennially to submit a report to DSD certifying the structural and electrical integrity of such facility. The City may conduct an independent inspection of such facility after receipt of such report pursuant to Section 40.618 (x) 3. Tenants of an antenna support structure may indicate "n/a" (not applicable) regarding questions associated with the antenna support structure holding their equipment but should respond to questions related to their specific equipment both on the ground and in the air.

Please provide complete answers to the following items on a separate sheet or sheets as necessary. Your responses should be certified by an engineer licensed to practice in Florida.

1.0	Please provide a summary of all modifications/changes/additions to the wireless facility (including additional tenants) including date of same, since the facility first obtained a certificate of completion from the City of Margate Building Department.
2.0	If the wireless facility is illuminated in compliance with FCC/FAA requirements, please provide a summary of all illumination failures (date and time of failure, length of time prior to restoration, cause of failure).
3.0	Please provide a copy of the most recent structural analysis of the wireless facility in your possession, together with a statement indicating what corrective measures were undertaken to address any matters cited in the structural inspection, if applicable.
4.0	Please provide certification that the wireless facility complies with all OSHA/DEP/EPA regulations regarding the storage of hazardous materials.
5.0	Please state if there have been any accidents at the wireless facility which have invoked Florida's worker's compensation regulations and if so, please provide copies of any reports regarding such accidents.

6.0	Please provide certification that the composite radio frequency (RF) emissions for the wireless facility (calculated using all wireless spectrum being transmitted from the wireless facility) is less than the maximum exposure threshold limits set forth under applicable federal regulations.
7.0	In the event the wireless facility has received a violation for exceeding maximum radio frequency emissions, please provide a copy of said violation and a statement as to the corrective actions taken to restore compliance with applicable federal regulations.
8.0	Please state the date of the last visual inspection of the wireless facility and describe the physical condition of same, including any observed rusting or corrosion of any component of the wireless facility as well as any observed unsecured or under secured attachments, feed lines, guy wires, etc.
9.0	Please state if there are any federally required signs at the wireless facility and if so, the applicable registration numbers and contact information required by federal regulations to be contained on such signage.
10.0	Is security fencing required at the wireless facility? If so, is it intact and are the locking mechanisms/devices operational?
11.0	Is the wireless facility physically accessible or blocked by vegetation? Is the surrounding landscaping free from excess growth? Are tenant compounds/buildings/cabinets in good repair and free from excess vegetation growth?
